**We require payment up front to hold your space and the rental fee is non-refundable. Your space is not guaranteed until payment has been received. We are covering the Vendor Insurance for the event as well.**

By signing this, you agree to the following:

1. You are responsible for bringing your own tables, setting up and taking down your booth and cleaning your area completely. If you need a table, we will be able to rent them, and this will need to be paid with your application fee.
2. We are going to have a lot of advertising for this event, you agree to be there the full time of the event and not leave early. Set up will begin at 5:00pm December 20, 2024 and take down at 4:00pm December 22, 2024. If you break down early, you will not be invited back

3. You will treat all vendors there with respect and not be interrupting customers when they are at another vendors booth. Speaking negatively about another vendor or downgrading their products will be grounds to ask you to leave.
4. You are allowed to sell whatever you would like except for firearms and alcohol.
5. You are responsible for all your own items, we are not responsible for lost, stolen or broken items. Security will not be provided.
6. Your fee for the booth covers the advertising, payment is expected up front and is **non-refundable**.
7. Vendor and any employees agree to maintain a level of professionalism, clean clothing hair and personal hygiene.
8. Vendors will be able to pull up front to unload and load but agree to move their vehicle to the back of the parking lot to make sure our customers have the best parking available.

We want this to be an enjoyable event for our customers and a profitable event for our vendors.
